PRODUCT DESCRIPTION:

The F-62 FR A/B system is a production oriented fire retardant system. It features a work time which allows time to vacuum de-air and cast detailed or large parts by hand, or by use of metered dispense equipment.

CURE SCHEDULE/HEAT CURING:

Most of the physical properties can be achieved in 5-7 days at ambient temperature, 77°F (25°C). In order to achieve maximum physical properties, a post cure with heat is required. BJB recommends 24 hours at ambient temperature, 77°F (25°C), followed by 16 hours at 160°F (71°C).

STORAGE:

Store at room temperature in a dry place. Unopened containers will have a shelf life of 6 months from date of shipment when properly stored under normal conditions at 75°F (24°C). NOTE: The F-62 FR A/B components, in liquid form, will darken with age. Opened containers of material should be purged with dry nitrogen prior to replacing lids or caps to prevent moisture contamination.

F-62 Part A may partially freeze below 65°F (18°C). Warming to 80°-90°F (27°-32°C) will return product to a liquid state.
